### Invitation to the Common Security and Defence Policy Train-the-Trainer Seminar

Within the framework of the European Security and Defence College (ESDC), Belgium has the honour to host the Common Security and Defence Policy (CSDP) Train-the-Trainer Seminar to be held in Brussels on 27 and 28 September 2011.

The targeted audience is made up of the academics/trainers that will be involved in the organisation and conduct of ESDC training activities and more specifically the module leaders and faculty members of the CSDP High Level Course and the Course Directors of Common Modules on CSDP in the framework of the European Initiative for the Exchange of Young Officers. In most cases they will belong to a department that gives training and education in international or political sciences and have at least a general understanding of the functioning of the EU Institutions and of the CSDP within the larger framework of CFSP.

The aim of the Seminar is to provide the participants with updated information on CSDP, to give an overview of existing training material, including the proper use of the ESDC IDL (Internet-based Distance Learning) system, and to provide the necessary skills to successfully moderate and conduct both the academic and practical parts of the training activities. Considering the different parts of the target audience some of the training will be organised using a dual track, whilst other parts will be conducted as plenary sessions.


